This course builds on AAP 111 and AAP 112. Students will develop an understanding of various forms of dementia with a focus on Alzheimer's disease, detailing the corresponding symptoms and disease progressions. This course applies program planning and implementation principles to clients experiencing dementia and cognitive decline. A brief overview of depression and delirium and suitable activities are discussed.

- identify and differentiate between dementia, delirium, and depression, understanding their unique symptoms and implement best-practice activity programming tailored to each condition; and

 demonstrate the ability to empathize with the challenges, emotions, and needs of caregivers for individuals with dementia, and provide targeted support to enhance the caregivers' overall well-being.
