# **Description:**

This course meets and exceeds the 2022 Edition NFPA 470 at the Core Operations (Chapter 7) and Mission Specific (Chapter 9.2 and 9.6) Hazardous Materials/Weapons of Mass Destruction (WMD) Standard for Responders. At this (Responder) level, students learn the skills and additional knowledge necessary to respond to hazardous materials or weapons of mass destruction (WMD) incidents and protect nearby persons, the environment, and property from the effects of the release.

## **Program Information:**

This course is a required course for the Fire Training Certification program. It is delivered as a standalone course as a part of a specialized contract training program.

## **Learning Outcomes:**

Upon the successful completion of this course, students will be able to perform the duties of an operations level hazardous materials responder according to the criteria set by the National Fire Protection Association, standard NFPA 470; i.e.:

- analyze a hazardous materials/WMD incident to determine the scope of the problem and potential outcomes;
- plan an initial response to a hazardous materials/WMD incident within the capabilities and competencies of available personnel and personal protective equipment;
- implement the planned response for a hazardous materials/WMD incident to favorably change the outcomes consistent with the emergency response plan and/or standard operating procedures; and
- evaluate the progress of the actions taken at a hazardous materials/WMD incident to ensure that the response objectives are being met safely, effectively, and efficiently.

#### **Evaluation Notes Comments:**

A grade of COM is awarded for a minimum of 70% on all theory based tests and a pass on all practical assessments.

The theory portion of the course is assessed with a Pro Board-approved written test. Students must achieve a minimum mark of 70%.

The practical skills portion of the course is assessed on a pass/fail basis. Students must earn a passing grade on each of the skills tests as required by the Pro Board.

A passing grade is required in both theory and practical skills components in order to earn credit for the course.

All courses (whether credit-bearing or continuing education courses) must be passed or marked "complete" according to the criteria listed before the student can be awarded the Fire Services Training Certificate.

#### **Exam Attendance:**

Students must attend all scheduled exams at the appointed time and place. Instructors may approve an alternate exam to accommodate an illness or personal crisis. Department heads will consider other written requests. Any student who misses a scheduled exam without prior approval will receive a "0" on the exam.
