Learning Outcomes:

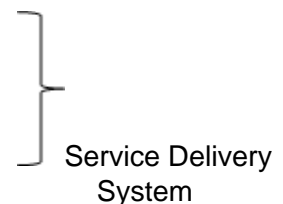
Upon the successful completion of this course, students will be able to:
