### **Description:**

Consolidated Practice 1 experience is designed to assist students to move forward with the health promoting focus of year one towards the focus on health challenges in year two. Students have opportunities to develop caring relationships with individuals and families, furthering the development of their assessment skills, some medication administration skills, and their understanding of health and health promotion. Students build confidence in all domains of nursing practice as they integrate knowledge from health and healing, applied health sciences, relational practice and professional practice courses.

health, healing, and health promotion;

- develop and implement learning plans to meet identified learning needs for individuals and groups;
- perform comprehensive assessments and connect findings to knowledge of holistic wellbeing and physiological processes;
- demonstrate critical thinking, skillful decision making, self-reflection, and self-evaluation through the integration of nursing knowledge;
- describe information literacy skills to support nursing practice;
- solicit and integrate input of individuals, families and other professionals from the interprofessional team to inform person-centered care;
- display initiative, a beginning confidence and self-awareness in collaborative interactions within the interprofessional team;
- discuss the influence of paradigms, worldviews and theories on one's own approach in nursing practice;
- demonstrate self-awareness by reflecting on positionality and social location while accommodating for difference with others;
- demonstrate cultural awareness and sensitivity to promote culturally safe health care; and
- demonstrate environmentally responsible practice.

# **Course Topics:**

# **Course Process:**

Students develop professional and safe nursing practice, critical thinking, and critical reflection. A variety of teaching methods will be used to address various learning styles and facilitate experiential learning, including simulation/interactive participation, demonstration, facilitation, discussion, role-modeling, critical reflection, audio/visual aids. Practice experiences are supported by praxis seminars which provide opportunities to examine theories and concepts for discussion, exploration, and integration. Praxis involves the examination of the dynamic interplay between theory and practice. Through praxis, students have opportunities to actively participate in the construction of their own knowledge. Praxis is actualized by critical reflection, journaling, and active participation in nursing practice seminars. Faculty also foster exploration of the role of the nurse in relation to the promotion of health and healing.
