#### **Program Area:** Health

#### **Description:**

The Health Care Assistant Program is designed to provide students with opportunities to develop the knowledge, skills, and attitudes necessary to function effectively as front-line caregivers and be a respected member of the health care team. Under the direction and supervision of a regulated health professional, graduates provide person-centered care aimed at promoting and maintaining the physical, psychological, cognitive, social and spiritual health and well-being of clients and families.

Upon completion of the program, graduates are prepared to work in a variety of practice settings, including home support, assisted living, group homes, complex care, special care units, other home and community care settings and acute care.

#### **Program Information:**

The Health Care Assistant program follows the 2023 HCA Provincial curriculum. The HCA Provincial curriculum (2023) is an updated document building on the 2008 and 2015 provincial curriculum. Since 2008, the working environments of HCAs have continued to evolve as the complexity of client populations has continued to increase. More HCAs are being employed in acute care settings and they are providing care for more acute clients than in the past. The curriculum includes information about the values, beliefs, and principles fundamental to the practice of the HCA, as well as foundational principles and concepts required for practice.

  - HCA students provide care to vulnerable clients in the practice education portion of the program and a clear police certificate from the country of origin is required prior to acceptance into the HCA Program. This applies to all international HCA program applicants, including those currently residing in Canada.
- English Competency Self-Declaration
- Notice of Collection, Use and Disclosure Agreement
- Computer Literacy Recommended.
