#### Program Area: Trades Apprenticeship Training

#### **Description:**

The Level 2 Hairstylist Apprenticeship program is designed to provide hairstylists who have completed a Hairstylist Foundation program or Level 1 Hairstylist apprenticeship program an opportunity to obtain Red Seal qualification. In this program, hairstylists develop and enhance their skills in client services, haircutting, styling and colouring, as well as develop specialized skills in hair extensions and applying wigs and hairpieces. The Level 2 Hairstylist program also develops business management skills and apprentices learn to develop a business and marketing plan for a salon. Safe work practices related to the hairstylist industry are reinforced throughout the program

#### **Credentials Granted:**

Upon successful completion of the Level 2 Hairstylist, program students receive:

• Level 2 Technical Training credit of the Hairstylist program from SkilledTradesBC

#### Final in-school percentage score

Apprentices must achieve a minimum 70% as the final inschool percentage score to be eligible to write the Interprovincial Red Seal exam.

### Pass Requirements:

All apprentices who complete Levels 1-2 of the Hairstylist Program with a FINAL level percentage score of 70% or greater will write the Interprovincial Red Seal examination as their final assessment.

SkilledTradesBC will enter the Apprentices' Interprovincial Red Seal examination percentage score in STBC Direct Access. A minimum percentage score of 70% on the examination is required for a pass.

Upon passing the Interprovincial Red Seal examination, the apprentice will then be able to eligible to take the BC Hairstylist Practical Exam. After passing the practical exam, the apprentice will be granted the Interprovincial Red Seal endorsement on their Certificate of Qualification
