Description:

The curriculum for the Human Service Worker Program (both certificate and diploma levels) reflects the growing responsibilities and practice standards for graduates employed in the field. Students develop a theoretical knowledge base, a foundation of professional ethics and values, a critical thinking ability, essential support skills and a process for integrating all their learning into a practice framework.

The Human Service Worker program combines academic study with practical experience to provide graduates with the skills, knowledge and attitudes required to work in the diverse and complex field of community and social services.

Program Information:

1. HSWR Certificate (1st year): can be completed in 3 semesters of full-time study (or a maximum of 3 years of part-time study) fully online or a combination of the face to face and online. The HSWR Certificate consists of 12 courses and 2 practica (180 hours each), for a total of 44 credits.
The HSWR certificate prepares students for entry level work in government and community agencies that support youth, adults and families facing challenges as a result of intrapersonal, interpersonal and societal factors.
2. HSWR Diploma (2nd year): HSWR 2nd year courses are offered online and can be completed within 3 semesters of part-time study for a further 18 credits. The successful completion of both 1st and 2nd year courses constitutes a HSWR Diploma. The HSWR Diploma prepares students to work in specialized areas in the human service field. In addition, some employers require a diploma for supervisory positions.
3. Citation: The citation is available for uncertified Human Service Workers who are currently working in the field and would like to engage in professional development. The citation

consists of five courses at the diploma level for a total of 15 credits. Students are still required to meet admission requirements for the HSWR program. The Human Service Worker Citation program outline is listed separately; please see "HSWC" on the course outline website.

Credentials Granted:

Human Service Worker Diploma

Minimum Course Grade: A minimum grade of C in CYFS courses and a minimum grade of D in University Art and Science courses

Program Average: A minimum program grade point average of 2.0/10 (C- average)

Program Goals and Career Pathways:

At present, the majority of HSWR students continue from the Certificate to the Diploma with success. While many continue into a degree in social work (BSW) or child and youth care (BCYC), some have shown an interest in other degree opportunities such as the Bachelor of Community Rehabilitation or a Bachelor's in Psychology or Addictions.
