Description:

This two-year diploma program is designed to help prepare graduates to give qualified professional care to individuals and families in a variety of settings. Graduates are eligible to apply to write REx-PN exams for licensure as Practical Nurses. In order to meet requirements for clinical practica, students may have to travel to regional areas in the East Kootenay.

Within this curriculum, caring is viewed as a core concept. Practical Nurses foster client empowerment in care planning and decision making, and are cognizant of their unique biological, psychosocial, spiritual, cultural and environmental complexity. Practical Nurses care for clients across the lifespan, providing safe, knowledgeable and integrated care through critical thinking and clinical judgment.

The Practical Nurse curriculum supports a deliberate, client-focused approach, and fosters the development of a conscious relationship with the client and the learning environment. Learning occurs through formal and informal study, mentorship, coaching, role modeling and experience. Lifelong learning is facilitated by a learner-owned approach that promotes cultural safety, cultural humility, caring, independence, critical inquiry and creativity. The curriculum embraces concept-based, case-based, skill-based and integrated learning experiences, and builds on the learners' prior learning and life experience. Collaborative learning through interdisciplinary understanding and effective team functioning are promoted as well.

Program Information:

The curriculum framework of the Provincial Practical Nursing Program (PPNP) is guided by the Nurses (Licensed Practical) Regulation (2015), Entry-to-Practice Competencies for Licensed Practical Nurses (CCPNR, 2013), Professional Standards for Licensed Practical Nurses

(CLPNBC, 2014), Scope of Practice: Standards, Limits and Conditions (CLPNBC, 2017), and the Canadian Practical Nurse Registration Examination Blueprint (CPNRE, 2017).

English Language Proficiency Requirements

Applicants whose first language is not English will be required to achieve the following scores in one of the two tests below:

1. International English Language Testing System (IELTS) with minimum scores of

- Speaking: 7.0
- Listening: 7.5
- Reading: 6.5
- Writing: 7.0
- Overall Band Score: 7.0

2. Canadian English Language Benchmarks Assessment for Nurses (CELBAN) with minimum scores of:

- Speaking: 8.0
- Listening: 10.0
- Reading: 8.0
- Writing: 7.0

It is the applicant's responsibility to arrange for assessment through Student Services or an Education Advisor at the College.

- FOIPP Voluntary Self-Disclosure Practicum Requirements
- CPR for Health Care Providers BLS or HCP or equivalent, to be kept current for the duration of the program. Acceptable CPR courses must include a face-to-face component and may be combined with a first aid course
- BCCDC Immunizations for BC Health Care Workers
- Annual influenza immunization
- Negative TB testing results
